Beskrywing van Grense

Begin by baken A geleë in die noordoostelike gedeelte van die plaas Hoedklip 36 op die gemeenskaplike grens tussen die plase Hoedklip 36 en Paternoster 948; daarvandaan langs genoemde gemeenskaplike plaasgrens in 'n suidsuidwestelike rigting tot by die gemeenskaplike plaasbaken B; daarvandaan langs die grens van die plaas Hoedklip 36 in 'n suidoostelike rigting tot by die plaasbaken C; daarvandaan langs die plaasgrens in 'n suidsuidoostelike rigting tot by 'n punt waar dit die hoogwaterlyn van die Atlantiese Oseaan ontmoet; daarvandaan langs die hoogwaterlyn in 'n algemeen noordelike rigting tot by 'n punt regoor baken D; daarvandaan in 'n reguit lyn oor baken D tot by baken A.

VREDENBURG MUNICIPALITY: ESTABLISHMENT OF NATURE RESERVE

Under section 54 (1) (a) of the Nature Conservation Ordinance, 1965 (Ordinance 26 of 1965), I hereby establish a nature reserve in the magisterial district of Vredenburg, assign the name "Columbine Nature Reserve" thereto and define the boundaries thereof as set out in the Schedule hereto.

SCHEDULE

Description of Boundaries

Begin at beacon A situated in the north-eastern portion of the farm Hoedklip 36 on the common boundary between the farms Hoedklip 36 and Paternoster 948; thence along the said common farm boundary in a south-south-westerly direction to the common farm beacon B; thence along the boundary of the farm Hoedklip 36 in a south-easterly direction to the farm beacon C; thence along the farm boundary in a south-easterly direction to a point where it meets the highwatermark of the Atlantic Ocean; thence along the highwatermark in a general northerly direction to a point opposite beacon D; thence in a straight line over beacon D to beacon A.

Portions 1 and 2 of the farm Hoedklip 36 are excluded from the area.

VREDENBURG-SALDANHA MUNICIPALITY: BY-LAW RELATING TO THE COLUMBINE NATURE RESERVE

Definitions

a, In this by-law —

"Council" means the Municipal Council of Vredenburg-Sal-

"official" means an official employed by the Council;

"Reserve" means the Columbine Nature Reserve as defined in section 3 hereunder, and

"Town Clerk" means the Town Clerk of the Municipality of Vredenburg-Saldanha.

Nature Conservation Regulations to apply

2. The Nature Conservation Regulations promulgated under Provincial Notice 955 dated 29 August 1975, as amended, shall and mutatis mutandis in respect of the Reserve; provided that an eference in such regulations to the "Director" and the "Department" shall be construed as a reference to the Council.

Reserve defined

3. For the efficient management, control and development of the Columbine Nature Reserve, this by-law shall apply in respect of the area defined in Proclamation 458, 1973, dated 11 December 1973, but shall exclude the areas under the control of the South African Railways and Harbours Administration and the Department of Posts and Telecommunications.

MUNISIPALITEIT VREDENBURG-SALDANHA: VERORDENING INSAKE DIE COLUMBINE-NATUURRESERVAAT

Woordbepaling

- 1. In hierdie verordening beteken -
 - "beampte" 'n beampte in diens van die raad;
 - "raad" die Munisipale Raad van Vredenburg-Saldanha;
 - "reservaat" die Columbine-Natuurreservaat soos in artikel 3 hieronder omskryf, en
 - "stadsklerk" die stadsklerk van die Munisipaliteit Vredenburg-Saldanha.

Natuurbewaringsregulasies van toepassing

2. Die Natuurbewaringsregulasies afgekondig by Provinsiale Kennisgewing 955 van 29 Augustus 1975, soos gewysig, is mutatis mutandis van toepassing ten opsigte van die reservaat; met dien verstande dat enige verwysing in sodanige regulasies na die "Direkteur" en die "Departement" geag word 'n verwysing na die raad te wees.

Reservaat omskryf

3. Vir die doelmatige bestuur, beheer en ontwikkeling van die Columbine-Natuurreservaat is hierdie verordening van toepassing ten opsigte van die gebied soos omskryf in Proklamasie 458, 1973, van 11 Desember 1973, met uitsluiting van die gebiede onder beheer van die Administrasie van die Suid-Afrikaanse Spoorweë en Hawens en die Departement van Pos- en Telekommunikasiewese.
