STIGTING VAN 'N PRIVATE NATUURRESERVAAT**

Kennisgewing geskied hiermee kragtens artikel 12(4) van die Ordonnansie op Natuur- en Omgewingsbewaring, 1974 (Ordonnansie 19 van 1974), dat die Administrateur goedkeuring verleen het aan mnr. J. H. Zaaiman om 'n private natuurreservaat op sy eiendom, synde Gedeelte 35, 'n gedeelte van Gedeelte 34, van die Plaas Klipfontein Nr 414, Riversdal in die gebied van die Suid-Kaap-streeksdiensteraad te stig, waaraan die naam "Hannes Zaaiman Private Natuurreservaat" toegewys is en waarvan die grense is soos aangedui op 'n kaart geliaseer in die kantoor van die Hoofdirekteur: Natuurbewaring en Museums, Utilitas-gebou, Dorpstraat 1, Kaapstad.
