En nademaal daar by paragraaf (a) van subartikel (2) van artikel twee van die Ordonnansie op die Beskerming van Inheemse Flora, 1940 (Ordonnansie No. 9 van 1940), soos gewysig, bepaal word dat die Administrateur van tyd tot tyd by proklamasie in die *Offisiële Koerant van die Provincie Transvaal* een of meer reserwes vir inheemse flora kan instel;

So is dit dat ek, kragtens en ingevolge voornoemde bevoegdhede, en na verwysing na genoemde raad, hierby verklaar dat die gebiede in Bylae A by hierdie Proklamasie omskryf, voortaan wildreserwes en reserwes vir inheemse flora is waarop die bepalings van genoemde Ordonnansie van toepassing is, en dat genoemde reserwes bekend sal wees onder die onderskeidelike name soos in genoemde Bylae uiteengesit;

PROCLAMATION

BY THE HONOURABLE THE ADMINISTRATOR OF THE
PROVINCE OF TRANSVAAL.

Whereas it is provided in paragraph (d) of section eleven of the Game Ordinance, 1949 (Ordinance No. 23 of 1949), as amended, that the Administrator may, from time to time after reference to the Fauna and Flora Advisory Board, by proclamation in the *Gazette*, declare any defined area to be a game reserve;

And whereas it is provided in paragraph (a) of subsection (2) of section two of the Native Flora Protection Ordinance, 1940 (Ordinance No. 9 of 1940), as amended, that the Administrator may from time to time by proclamation in the *Provincial Gazette of the Province of Transvaal* establish one or more native flora reserves;

Now, therefore, under and by virtue of the aforesaid powers, and after reference to the said board, I do hereby declare that the areas defined in Schedule A to this Proclamation shall henceforth be game reserves and native flora reserves, to which the provisions of the said Ordinance shall apply, and that the said reserves shall be known by the respective names set out in the said Schedule;

And, I do further declare that the Proclamations set out in Schedule B to this Proclamation are hereby repealed.

BARBERSPAN NATURE RESERVE, DISTRICT DELAREYVILLE.


(Size: Approximately 4,233 morgen.)

Those portions of the farms Vergenoeg No. 52, Barberspan No. 72, Groenfontein No. 71, Zandvlei No. 53 and Leeuwpan No. 22, District Delareyville which are submerged under or surrounded by the waters of the pan known as Barberspan and an area one mile wide around the said pan and measured from the outer edge of the said waters.


